- 4. We will not include personal email or postal addresses, telephone or fax numbers on video, on our website, in our academy prospectus or in other printed publications.
- 5. We may use group or class photographs/footage with very general labels (i.e. "Science Lesson")
- 6. We will only use images of students who are suitably dressed to reduce the risk of such images being used inappropriately.
